# **User Agreement and Terms of Service**

Welcome to TorahNet! By accessing or using our platform, you agree to comply with and be bound by the following User Agreement and Terms of Service. Please read these terms carefully before using our services.

## 1. Acceptance of Terms

By registering for, accessing, or using TorahNet ("the Platform"), you ("User") agree to be bound by this User Agreement and Terms of Service ("Terms"). If you do not agree to these Terms, you may not use the Platform.

## 2. Description of Services

TorahNet is an online educational platform that connects service providers ("Instructors/teachers") with customers ("Students") seeking educational services. We facilitate the booking and payment process and provide a platform for communication and interaction.

#### 3. User Accounts

- 3.1 Registration: Users must create an account to access certain features of the Platform. You agree to provide accurate and complete information during the registration process and to update such information to keep it accurate and complete.
- 3.2 Account Security: You are responsible for maintaining the confidentiality of your account login information and for all activities that occur under your account. You agree to notify us immediately of any unauthorized use of your account.

### 4. Use of the Platform

- 4.1 License: We grant you a limited, non-exclusive, non-transferable, and revocable license to use the Platform for its intended purposes.
- 4.2 Prohibited Activities: You agree not to:
  - Violate any laws or regulations.
  - Post or transmit any infringing, defamatory, obscene, or otherwise objectionable content.
  - Impersonate any person or entity or falsely state or misrepresent your affiliation with any person or entity.
  - Engage in any activity that disrupts or interferes with the Platform.

 Engage in Off-Platform Transactions: Once an Instructor and a Student connect on the Platform, they are bound by agent-principal laws. All transactions for educational services facilitated through TorahNet must be conducted on the Platform. An "Off-Platform Transaction" refers to any payment or arrangement for services facilitated outside of TorahNet's payment and booking system. Violations of this clause will result in penalties, including but not limited to account suspension or permanent banning from the Platform.

## 5. Payment and Fees

- 5.1 Payment Processing: Payments are processed through our secure payment system. By using our payment services, you agree to our Payment Policy.
- 5.2 Service Fees: TorahNet charges a service fee for each transaction. The applicable service fees will be displayed to both Instructors and Students prior to confirming a booking.

### 6. Cancellation and Refunds

Cancellations and refunds are subject to our Cancellation Policy and Refund Policy. Please review these policies for detailed information.

## 7. Intellectual Property

- 7.1 Ownership: The Platform and its content, including but not limited to text, graphics, logos, and software, are the property of TorahNet and are protected by copyright, trademark, and other intellectual property laws.
- 7.2 User Content: By posting content on the Platform, you grant TorahNet a non-exclusive, royalty-free, worldwide, transferable license to use, reproduce, modify, and display such content.

## 8. Dispute Resolution

Any disputes arising out of or related to these Terms or the use of the Platform will be resolved through binding arbitration in accordance with our Dispute Resolution Policy.

## 9. Limitation of Liability

To the maximum extent permitted by law, TorahNet shall not be liable for any indirect, incidental, special, consequential, or punitive damages, or any loss of profits or revenues, whether incurred directly or indirectly, or any loss of data, use, goodwill, or other intangible losses, resulting from your use of the Platform.

### 10. Indemnification

You agree to indemnify and hold harmless TorahNet and its affiliates, officers, agents, and employees from any claim, demand, loss, or damages, including reasonable attorneys' fees, arising out of or related to your use of the Platform or violation of these Terms.

### 11. Modifications to Terms

We reserve the right to modify these Terms at any time. We will notify you of any changes by posting the new Terms on the Platform. Your continued use of the Platform after such changes constitutes your acceptance of the new Terms.

#### 12. Termination

We may terminate or suspend your account and access to the Platform at our sole discretion, without prior notice, for conduct that we believe violates these Terms or is harmful to other users or the Platform.

These Terms shall be governed by and construed in accordance with the laws of Israel, without regard to its conflict of law principles.
